# 1. Inspections

#### 1.1. Dates of Inspection

ONR site inspectors made inspections on the following dates during the report period 1 October-31 December 2021:

27 October

16 & 17 November

14 December

### Routine Matters

#### 2.1. Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- the conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- the Energy Act 2013
- the Health and Safety at Work Act 1974 (HSWA74); and
- regulations made under HSWA74, for example the lonising Radiations Regulations 2017 (IRR17) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

In this period, routine inspections of Oldbury covered the following:

- emergency preparedness;
- incidents on the site;
- fire safety;
- security

During the reporting period, ONR judged the arrangements made and implemented by the site in response to safety requirements to be satisfactory in the areas inspected. Where improvements have been identified, the licensee has made a commitment to

address those issues, and ONR inspectors will closely monitor progress during future site inspections. Where necessary, ONR will take formal regulatory enforcement action to ensure that appropriate remedial measures are implemented to reasonably practicable timescales. #### 2.2. Other Work

An ONR inspector met with the site safety representatives on 17 November 2021, to support their function of representing employees and receiving information on matters affecting their health, safety and welfare at work.

On 27 October 2021 an ONR inspector attended the Oldbury Site Stakeholder Group meeting.

#### 3. Non-Routine Matters

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

Matters and events of particular note during the period were:

Towards the end of the previous reporting period the licensee had notified ONR of the discovery on 22 September 2021 of unauthorised modifications to safety system interlocks on a pond crane at Oldbury site. ONR reviewed the circumstances surrounding the unauthorised modifications and identified compliance shortfalls against the Provision and Use of Work Equipment Regulations 1998 (PUWER) and the Lifting Operations and Lifting Equipment Regulations 1998 (LOLER). ONR noted that after the error had been identified, the licensee's reporting, investigation and rectification actions had been positive. ONR issued a regulatory advice letter to ensure sustained compliance with law. The licensee was advised to make changes to its PUWER and LOLER compliance arrangements, and to improve its supervision arrangements for future decommissioning activities. As part of ongoing routine regulatory activities ONR will monitor the licensee's progress against this regulatory advice.

4. Regulatory Activity

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs) but can take other forms. In addition, inspectors may take a range of enforcement actions, to include issuing an Enforcement Notice.

No LIs, Enforcement Notices or Enforcement letters were issued during this period.
