1. Inspections

1.1. Dates of Inspection

The ONR site inspector made inspections on the following dates during the report period 1 July to 31 December 2021:

- 26 July 2021 Magnox Ltd Winfrith Site
- 27 July 2021 Tradebe Inutec Ltd
- 19 October 2021 Tradebe Inutec Ltd

2. Routine Matters

2.1. Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- the conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- the Energy Act 2013;
- the Health and Safety at Work Act 1974 (HSWA74); and
- regulations made under HSWA74, for example the Ionising Radiations Regulations 2017 (IRR17) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

The inspections at the Magnox Ltd Winfrith site focused on the following Licence Conditions (LC) and safety regulations:

- LC8 Warning notices
- LC10 Training
- LC26 Control and supervision of operations

The inspections at the Tradebe Inutec Ltd site focused on the following Licence Conditions (LC) and safety regulations:

- LC6 Documents, records, authorities and certificates
- LC7 Incidents on site
- LC8 Warning notices
- LC9 Instructions to persons on site
- LC26 Control and supervision of operations
- The Construction (Design and Management) Regulations 2015

During the reporting period, ONR judged the arrangements made and implemented by the site in response to safety requirements to be satisfactory in the areas inspected. Where improvements have been identified, the licensee has made a commitment to address those issues, and ONR inspectors will closely monitor progress during future site inspections. Where necessary, ONR will take formal regulatory enforcement action to ensure that appropriate remedial measures are implemented to reasonably practicable timescales. 2.2. Other Work

Throughout this reporting period, including the period of national lockdown, ONR's nominated site safety inspector has held regular telephone meetings with the ML Winfrith and Tradebe Inutec Ltd leadership team representatives to maintain situational awareness of matters related to nuclear safety. No significant issues were highlighted to ONR.

ONR continue to monitor the implementation of COVID-19 arrangements at Winfrith on both the Magnox Ltd and Inutec Ltd sites, it was the opinion of the site inspector that this was in accordance with government guidance and arrangements were in place to reduce the risk from COVID-19 to as low as reasonably practicable.

In August 2021, ONR issued a letter of no objection for Magnox Ltd Winfrith to commence specified building and civil works on the Steam Generating Heavy Water Reactor (SGHWR). The decision was based upon assessment of the proposals by ONR specialist inspectors supported by sites visits and inspections. The building and civil works are enabling works to support the planned decommissioning of the SGHWR.

In November 2021, Magnox Ltd Winfrith notified to ONR its intention to amend approved emergency arrangements under license condition 11. ONR has conducted a preparatory visit at Magnox Ltd Winfrith site to support a demonstration exercise of the new arrangements during 2022. The results of the exercise will be utilised to inform ONRs decision to approve the revised emergency arrangements.

Non-Routine Matters

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

There were no such matters or events of significance during the period.

4. Regulatory Activity

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs) but can take other forms. In addition, inspectors may take a range of enforcement actions, to include issuing an Enforcement Notice.

No LIs, Enforcement Notices or Enforcement letters were issued during this period.
