1. Inspections

1.1. Dates of Inspection

The ONR site inspector made inspections on the following dates during the report period 1 April – 30 June 2022:

Licence Conditions 14 & 15 on 7 June 2022

2. Routine Matters

2.1. Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- the conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- the Energy Act 2013;
- the Health and Safety etc at Work Act 1974 (HSWA74); and
- regulations made under HSWA74, for example the Ionising Radiations Regulations 2017 (IRR17) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring the licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

In this period, routine inspections of Sizewell A covered the following:

safety documentation and the periodic review of safety cases.

This planned inspection targeted the licensee's arrangements for the production and implementation of safety cases, and also the periodic review of the site's safety case. These arrangements are well established, and no issues were found during the inspection. The inspection was rated as Green under the ONR inspection rating guide.

Additionally, ONR conventional health and safety inspectors visited the site to seek information on the demolition activities planned to commence in the near future. This visit will inform the ONR permissioning of these activities.



The Magnox SE Sites Annual Regional Review of Safety, Security and the Environment was held at Sizewell A on 10 May.

3. Non-Routine Matters

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

Two such matters were reported to ONR during the period: a high dose rate item had been located and safely recovered in the ponds during the final stages of clean up. A respirator hose became disconnected while working in a contamination area. The ONR site inspector is satisfied with the reporting of these matters and the actions taken to deal with them.

4. Regulatory Activity

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs) but can take other forms. In addition, inspectors may take a range of enforcement actions, to include issuing an Enforcement Notice.

 No LIs, Enforcement Notices or Enforcement letters were issued during this period.
